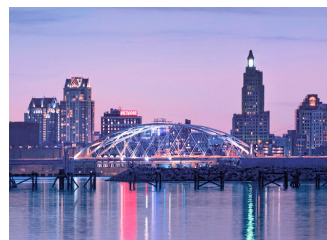




### Registration Now Open for 2016 NASEO Annual Meeting in Providence, Rhode Island
