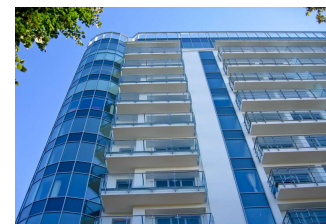
Rocky Mountain Compromise: Inside Xcel's Landmark Colorado Solar Settlement
