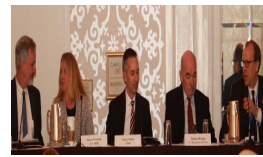
#### NASEO Convenes Experts, Including EPA Administrator McCarthy at State CPP Workshop

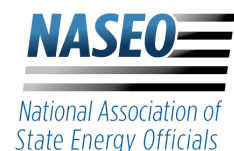
## Detailed Budget Comparison and Highlights from the President's FY'17 Budget Request
