The U.S. Environmental Protection Agency (EPA) recently released this year's ENERGY STAR Top Cities list, showing which U.S. metro areas were home to the most ENERGY STAR certified buildings for last year. EPA ranked the Top 25 Cities overall, the Top 10 Mid-Size Cities, and the Top 10 Small Cities.

GRID Alternatives Mid-Atlantic is working with the District's Department of Energy and Environment and the Department of Employment Services to implement and install solar power for low- to moderate-income families for free in Washington, DC.
