
Govenor Snyder Reorganizes Michigan Agency for Energy and PSC

Repeal of Qualified Energy Conservation Bonds Effective After December 31, 2017

On December 22, 2017, President Trump signed the Tax Cuts and Jobs Act (HR 1), which makes widespread amendments to the Internal Revenue Code. Section 13404 of HR 1 provides for the repeal of tax credit bonds, including Qualified Energy Conservation Bonds (QECBs).



2017 Costliest Severe Weather Year Ever - Reinforces "All Hazards" Energy

Emergency Preparedness

Last year set a record for costs incurred as a result of severe weather events according to the National Oceanographic and Atmospheric Administration (NOAA). In all, 2017 storm damage totaled \$306 billion due in large part to costs from a number of significant severe weather events.
