The Department of Mines, Minerals and Energy, Division of Administration/Energy is seeking an individual to support state energy and utility regulatory policy analysis and development. The Executive Branch relies on DMME to track and analyze barriers and solutions to advance energy policy objectives. This requires an understanding of all aspects of energy policy; extraction and utility regulation; ratepayer-funded conservation and efficiency programs; energy infrastructure development programs; and the knowledge, skills and ability to provide expert energy policy advisement and strategy recommendation. Additionally, this position serves as a backup to DMME's legislative liaison and regulatory coordinator. This position has been designated as required to file a Statement of Economic Interest in accordance with Section 2.2-3114 of the Code of Virginia. Individual accepted for employment will have to pass a drug and alcohol test as part of the DMME pre-employment process.

TO QUALIFY: Knowledge of current and emerging federal, state and local policies, resources and technologies related to energy and utility regulatory policy, including EM&V, energy markets and infrastructure. Knowledge of Virginia utility regulatory structures and processes. A strong working knowledge of computer business and communications application software (Microsoft Office Suite) required. Ability to manage multiple projects simultaneously. Ability to communicate effectively orally and in writing and to analyze complex information quickly is required. Ability to establish and maintain effective working relationships with customers and internal and external stakeholders is required. Previous experience in policy analysis is helpful. A college degree in public administration, business administration or environmental science preferred or, any equivalent combination of experience and training which provides the required knowledge, skills, and abilities. Previous experience in energy regulation; in the legislative and regulatory processes; policy research and analysis is preferred. Considerable knowledge of Legislative Information System, Regulatory Town Hall and Regulation Information System strongly desired.
