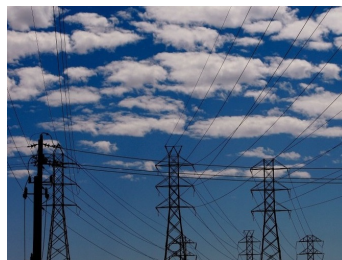
NASEO TESTIFIES IN SUPPORT OF FY'15 DEPARTMENT OF ENERGY FUNDING

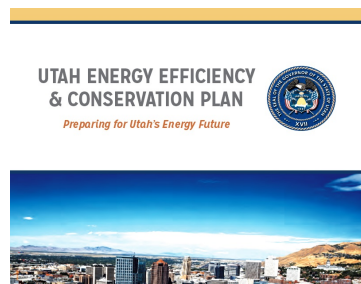
COLORADO PREPARES TO ISSUE RFP FOR CNG CO-FUELING LOCATIONS
