




**U.S. DOE Requests Comments on Streamlining

Connecticut Green Bank Strengthens Commitment to Low-Income Residents



Rhode Island Program Financing Commercial Energy Efficiency Projects Expected To Expand

A program designed to finance projects to make commercial buildings more energy efficient is growing in Rhode Island. Thirteen more municipalities are working to participate in the Rhode Island Commercial Property Assessed Clean Energy program, as fourteen others have already joined since the program launched in May 2016.



Nebraska's Wind-Energy Generation Passes 1000 Megawatts

With the raising of Grand Prairie, a 400-megawatt wind farm in Holt County, Nebraska has sailed past 1,000 megawatts - or 1 gigawatt - of wind-generated capacity. It's the 18th state to join the club, according to the American Wind Energy Association.



Minnesota Sees an 80 Percent Jump in Solar Energy Capacity this Year

Minnesota's solar energy capacity rose 80 percent during 2017's first three months, the second consecutive quarter of leapfrog growth.



Massachusetts Electric Companies and DOER Propose RFP for Offshore Wind Clean Energy Projects

On April 28, 2017, the Massachusetts investor-owned electric distribution companies, in coordination with the Massachusetts Department of Energy Resources (DOER), submitted for review proposals for up to 800 megawatts of offshore wind and associated transmission to enter into long-term contracts of 15 - 20 years.



Hawaii Airports Upgrading to LED Lights, Solar Systems

The Hawaii Department of Transportation (HDOT) has initiated the second phase of an energy savings initiative that will save more than \$606 million in energy costs at Hawaii's airports over a 15-year period.



Maryland Public Service Commission Approves 368 Megawatts in Offshore Wind Projects

Maryland regulators recently approved two offshore wind projects totaling 368 megawatts, setting in motion what the state called the nation's "first large-scale" offshore wind deployment.



Updated Guidebook for Energy Efficiency Cost-Benefit Analysis Issued

A comprehensive national guide for utility-funded energy efficiency programs has been issued to help utilities, regulators, State Energy Officials, and other stakeholders make better energy efficiency decisions for their jurisdictions.
