
17 Governors Commit to New Climate Action

CTC Global Tool Calculates Savings and Resilience Opportunities

CTC Global is offering a worksheet that calculates potential energy and emissions cutbacks. These calculations demonstrate that a 30% reduction in transmission and distribution (T&D) losses nationally would result in almost 59 million MWh of energy savings and almost 28 million metric tons of CO₂ reduced.
