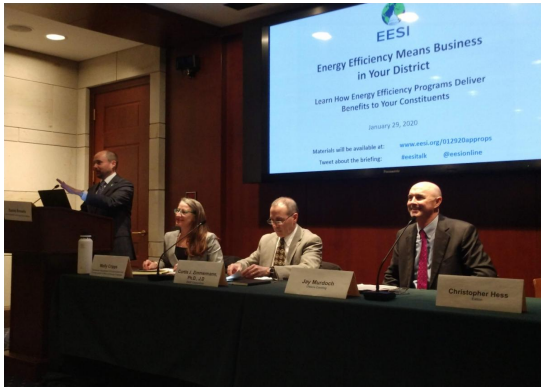
IRS Announces Long-Awaited Guidance on "45Q" Carbon Credit

On February 19, 2020, the Internal Revenue Service (IRS) released guidance and a revenue procedure on the "45Q" tax credit for companies using carbon capture equipment. The credit provide \$20 per metric ton of qualified carbon oxide capture at facilities whose construction starts before 2024.
